### **WARRANTY FORM**

We confirm, for the period starting at the handing over date as indicated on the Handing Over Certificate and ending twelve months after (or fourteen months from date of our invoice, whichever is sooner), that the equipment is guaranteed against defects and failures that appear therein under proper use and maintenance and arise solely from faulty materials or workmanship.

As of date of our invoice (date of arrival of goods to warehouse), any delay in equipment handing over for reasons imputable to client (site not ready, postponement of installation, etc) shall not entitle the equipment to any extension of warranty beyond the afore mentioned period.

Therefore and unless otherwise stated, it is understood that:

#### **Such warranty shall cover:**

1. The replacement, exchange or repair, free of charge, of all components or parts found defective or malfunctioning due to a manufacturing defect including vacuum articles, such as X-Ray tubes, Image Intensifiers and TV camera tubes. The spare-parts delivery is understood Loco/Hospital, hence, all clearing charges including customs duties and associated taxes and expenses are on our charge.
2. The supply, free of charge, of manpower labor for corrective calls, preventive maintenance and calibration procedures as set by the manufacturer.
3. The supply, free of charge, of all hardware and software updates which are issued by the manufacturer during the warranty period, mandatory for safety and/or effectiveness of the equipment as presently configured and delivered.

#### **Such warranty shall not cover:**

1. The supply of any consumable part or goods liable to deterioration such as articles made of rubber, flexible leads, lamps, films and chemicals.
2. Lifetime limited articles such as: Electrodes, Shock Wave Generators, Sensors, etc...
3. Gas and Cryogen agents, i.e. liquid Helium, gas Helium, HCF, Nitrogen, etc...
4. Hardware and software upgrades developed by the manufacturer, which concern the implementation of new functionality, technology or improvement of the system performance, not configured at date of purchase.
5. Any fault, damage or malfunction which arise from operator misuse, let it be breakage, perforation, utilisation of the equipment outside the scope of the intended use as defined by the manufacturer, and / or any kind of misuse. For such repairs, whether performed locally or at the manufacturer's premises, a quotation covering labor, parts and handling, shall be issued for approval by the customer after which the repair shall take place.
6. Damages sustained to improper environment conditions as compared to published technical specifications, i.e. mains supply, water supply, air-conditioning, natural catastrophes such as earthquake, flood etc..., or manmade catastrophes such as war, strike, etc...
7. Installation, modification and/or improper repairs made by the Client's staff or third parties not authorized in written by the Seller.

#### **General Terms :**

1. The client shall notify us about any material or manufacturing defects immediately after their detection.
2. Warranty claims of the client other than stipulated above shall be excluded.
